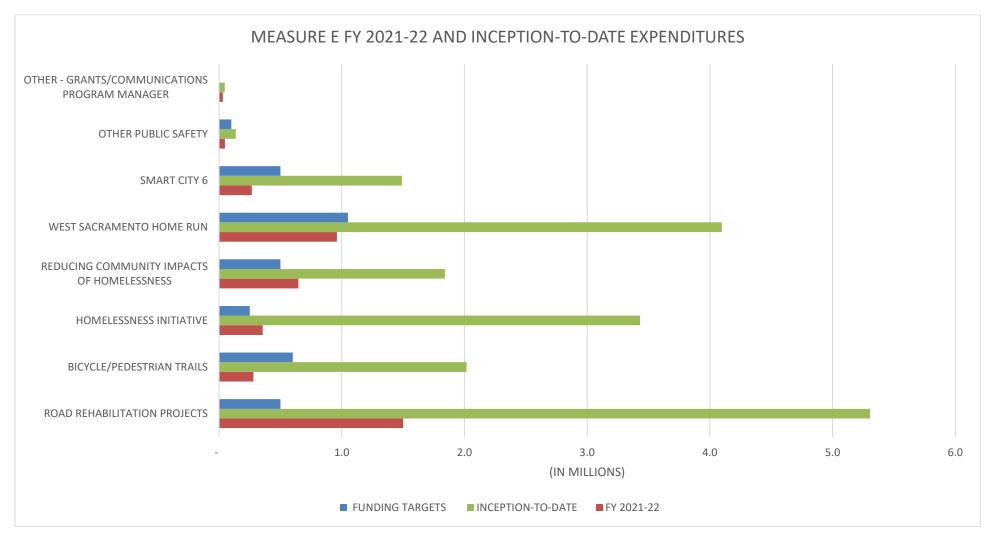
## **MEASURE E REPORT**

## **Overview**

In November 2016, West Sacramento voters approved Measure E, which imposed a permanent City-wide one-quarter (1/4) cent sales tax. The ballot language identified several areas of focused investment which included City services and initiatives, such as repairing roads, building and maintaining bicycle/pedestrian trails, reducing homelessness and it community impacts, improving educational and career opportunities for youth, and enhancing internet access and the use of smart technologies. These priorities were outlined in a Council adopted Measure E Universal Policy document to help ensure that the outcomes envisioned by Measure E are achievable within the available revenues.

In the information presented in the attached chart and table, *Appropriations* refers to the allocation of Measure E revenue in accordance with Measure E Universal Policy document, while *Actuals* refers to actual disbursement of those funds.

12021-22 expenditures include funding for the following projects: 1) Neighborhood Pavement Preservation Program project, 2) Arterial Street Pavement Repair project, 3) On-Call Striping Program, and 4) State Streets Pavement Rehabilitation Project

2 2021-22 expenditures include funding for the following projects: 1) Sycamore Trail Phase 3, 2) Southport Levee Recreation Trail Planning and Design, 3) Barge Canal Trail Phase I, and 4) Bees Lake Habitat Restoration Plan and Public Access Improvements.

3 2021-22 expenditures include funding for the Downtown Streets program.

4 2021-22 expenditures include funding for 1) staffing of 4.0 FTEs including a Senior Program Manager, Program Associate, Senior Park Maintenance Worker and Groundskeeper, 2) maintenance of

structures/grounds related to grazing services, mowing contract, power washing, tree trimming/removal and pesticide spraying service, and 3) operations and maintenance costs for the Rodeway Inn related to Project Homekey.

5 2021-22 expenditures include funding for 1) staffing of 4.5 FTEs including a Business Manager, Senior Program Manager, Program Associate, Program Manager and 0.5 Data Services Manager, 2) internship program, 3) early learing specialist contracts to perform training, coaching, assessment and ratings of preschools participating in Home Run, 4) Scholarshare 529 College Savings Account program, 5) Los Rios College Promise Tuition program, and 6) preschool scholarships.

6 2021-22 expenditures include funding for 1) staffing of 0.83 FTEs including 0.5 Data Services Manager and 0.33 Deputy City Manager, 2) Zoll Data Systems maintenance costs, 3) ZenCity Technologies

7 2021-22 expenditures include funding for staff overtime costs and operational expenses realted to community and youth engagement events.

8 2021-22 expenditures include funding for a 0.5 FTE Administrative Analyst I/II/Senior.
