

RESOLUTION 13-69

**A RESOLUTION OF THE CITY COUNCIL  
OF THE CITY OF WEST SACRAMENTO  
RESCINDING RESOLUTION 11-5 AND ESTABLISHING THE CITY'S POLICY FOR THE  
ISSUANCE OF FIREWORKS PERMITS PURSUANT TO CHAPTER 8.12 OF THE WEST  
SACRAMENTO MUNICIPAL CODE**

**WHEREAS**, on March 2, 2011 the City Council adopted Ordinance 11-2 repealing and reenacting Chapter 8.12 of the West Sacramento Municipal Code regulating the possession, sale and use of fireworks within the City of West Sacramento; and

**WHEREAS**, Chapter 8.12 of the Municipal Code requires the City Council to set by resolution the maximum number of permits to sell fireworks issued to qualified applicants; and

**WHEREAS**, on March 2, 2011 the City Council adopted Resolution 11-5 establishing the City's administrative policy for the issuance of fireworks permits pursuant to Chapter 8.12 of the West Sacramento Municipal Code; and


**WHEREAS**, after three seasons of fireworks sales, it is desired to amend the adopted permit allocation prescribed by Resolution 11-5; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of West Sacramento does hereby determine and order as follows:

1. The maximum number of permits to sell fireworks issued to qualified applicants shall be eight (8) and shall be allocated as follows:
  - 2 permits to qualified applicants in the category of Arts, Culture & Education
  - 2 permits to qualified applicants in the category of Service
  - 2 permits to qualified applicants in the category of Youth
  - 2 permits to qualified applicants that were not selected in the category drawings
  - In the event that any category does not receive 8 or greater entries, that category will receive only one permit. The remaining permit for the category will be given to the At-Large category.
2. All complete applications to enter the random drawing shall be filed with the City Clerk during normal business hours (8:00 am – 5:00 pm) March 1-March 31 of each year.
3. The random drawing for permits to sell fireworks will be held on or before April 10 of each year. All random drawings will be held at City Hall.
4. The non-refundable random drawing application fee shall be twenty-five dollars (\$25).
5. The permit fee to sell fireworks is three-hundred dollars (\$300).
6. At the conclusion of each year's fireworks sales, the Fire Chief shall furnish a report to the City Manager detailing incidents involving fireworks and enforcement efforts the City has undertaken.
